

## Privacy Policy

In compliance with the provisions of Law 15/1999, of December 13, Protection of Personal Data, we inform the users of this website that NGSC complies with all obligations, duties and guarantees to which it is obliged under the provisions of current legislation on protection of personal data and complementary regulations.

The data provided by the USER to NGSC , when completing the web form, will be included in a database owned and managed by NGSC , an entity with registered office at 22 Km Cairo-Alex Desert Road-Newgiza Sports Club -Al Giza Desert - 3296160 , holder of Tax ID number

By providing personal data to NGSC, the USER consents and authorizes the automated processing of his/her personal data by NGSC, which guarantees through this PRIVACY POLICY the absolute confidentiality of all personal data provided by the USER. In this sense, the USER undertakes, for its part, to maintain the same confidentiality about all data provided, and particularly with regard to their private passwords.

The automated processing of data provided by Users NGSC will have as main purpose to enable or facilitate the management of a more personalized service to the USER and ensure proper provision of the service contracted by the USER. Also, your data may be used for statistical and advertising purposes, offering new products and promotions offered by NGSC or third parties.

**Rights of users:** In accordance with the provisions of Title Three of Law 15/1999, of December 13, Protection of Personal Data, USERS are informed of the possibility of exercising, if they deem it appropriate, and without good cause, the rights of access, rectification, cancellation and opposition of their personal data by contacting NGSC, located in 22 Km Cairo-Alex Desert Road-Newgiza Sports Club -Al Giza Desert - 3296160 with CIF

- Right of access: The interested party shall have the right to request and obtain, free of charge, information about his or her personal data undergoing processing, the origin of such data, and the communications made or planned to be made of such data. The information may be obtained by simply consulting the data by means of visualization, or by indicating the data being processed by means of writing, copy, telecopy or photocopy, certified or not, in legible and intelligible form, without using codes or codes that require the use of specific mechanical devices.

This right may only be exercised at intervals of not less than twelve months, unless the interested party proves a legitimate interest to that effect, in which case it may be exercised earlier.

- Right of rectification and cancellation: Personal data whose processing does not comply

with the provisions of Law 15/1999 and, in particular, when such data are inaccurate or incomplete, may be rectified or canceled, if necessary. NGSC will enforce the right of rectification or cancellation of the person concerned within ten days.

The cancellation will result in the blocking of the data, being kept only at the disposal of the Public Administrations, Judges and Courts, for the attention of possible liabilities arising from the treatment, during the period of prescription of these. Once this period has expired, the data will be deleted. In the event that the rectified or canceled data had been previously communicated, NGSC will notify the rectification or cancellation made to whom they have been communicated, in the event that the treatment is maintained by the latter, who must also proceed to the cancellation.

For procedures in which the rights of opposition, access, rectification or cancellation are exercised, the provisions of the regulations shall apply, without any consideration being required.

**Obligatory nature of the information provided by the User:** The data provided by the User in the registration procedure must always be true and accurate, being obliged to communicate any changes made in them. The data to be completed in said procedure are those that have been considered pertinent, adequate and not excessive in relation to the purpose for which they were obtained. In case of refusal by the User on any of the requested data, NGSC reserves the right to exclude the User from accessing and using the contents and services of this website.

**Transfer of data:** It is considered expressly granted consent for the transfer of data collected in the order form of the web <http://ngscsports-egy.matchpoint.com.es/> when this transfer is made to suppliers necessary to fulfill the purpose of the file.

**Security and cookies:** NGSC guarantees users that its website complies with the security levels established in the regulations on data protection, and that it uses all technical means at its disposal to prevent any alteration, loss, unauthorized access or misuse of such data.

NGSC informs the User about the use of cookies on this website. Cookies are temporary files that, through its automatic insertion in the user's computer, can provide personalized content to it. Notwithstanding the foregoing, it is reported that the cookies used are associated anonymously with both the User and their equipment, so that no reference is provided in relation to the User's personal data. In any case, the User may modify the configuration of your computer, through the toolbar of your Internet browser, disabling or deleting all cookies if it deems appropriate.

This Privacy Policy may be modified when necessary. In case of modifications, we will inform you through the website or by other means, in order to inform you about the new Privacy conditions. The fact of continuing to make use of the functionalities made available by NGSC. after having notified you of the referred modifications will mean that you agree with them, except for the cases in which your express consent is necessary.

### **Who is responsible for the processing of your personal data?**

The responsible for the treatment of personal data is the entity NGSC , by completing the form on the web, will be incorporated into a database which is owned and responsible NGSC , an entity with registered office at 22 Km Cairo-Alex Desert Road-Newgiza Sports Club -Al Giza Desert - 3296160 , provided with CIF number (NIF)

### **For what purposes do we process your personal data?**

Personal data provided by users of this website will be processed for the following purposes:

1. Contact and management of users of the websites: The personal data of users who contact NGSC, will be processed in order to manage such contact, meet the requests received through the same and provide the required services, such as, where appropriate, provide care services to the person concerned.
2. Commercial, promotional or advertising communications of products and services of NGSC: The personal data of users may be processed by NGSC. in order to send advertising, promotional or information that may be of interest, only if the user had

consented to such purpose of data processing, by expressly accepting the box for commercial, promotional or advertising communications.

### **What data is processed by NGSC and from what sources?**

The data that NGSC. treats as a result of the interactions made by the user through our website come from the following sources: made available by NGSC. the relationship between the user and NGSC.

NGSC. may process personal data of the following types, depending on the relationship established with the user: Identification and contact data (e.g. name and surname, e-mail, postal address, telephone, etc.).

What is the legal legitimacy for the processing of your data by NGSC?

NGSC. treats the personal data provided by the users of its web pages in accordance with the following legitimate bases, depending on the type of data provided by the user, as well as the interactions that the user enters into with NGSC:

1. The processing of your data for the purpose of "Contact" is based on the management and processing of the legal relationship between the user and NGSC, that is, in the management of your own request, in the maintenance of contact between the parties and, where appropriate, in the provision of the service that the user had requested.

To whom is your data communicated?

Your personal data will not be disclosed to third parties.

**How long do we keep your data?**

Personal data will be kept for the duration of the relationship established with NGSC, as well as for the required legal periods.

### **What guarantees do you need to provide us with your personal data?**

The user guarantees that the data provided are true, accurate, complete and up to date, being responsible for any damage or loss, direct or indirect, that may be caused as a result of the breach of such obligation.

In the event that the user provides data belonging to a third party, he/she guarantees that he/she has informed said third party of all the aspects contained in this Privacy Policy and obtained his/her consent to provide us with his/her data for the purpose of the processing in question.

NGSC. informs you that to provide your personal data, in any way, through our website, you must be over 16 years of age. The user who provides data to NGSC. through this website declares and guarantees to be over 16 years of age, taking full responsibility for such statement.

### **What measures do we take to protect your personal data?**

In response to the concern of NGSC. to ensure the security and confidentiality of your data, we have adopted the security levels required for the protection of personal data and have installed the technical means at its disposal to prevent the loss, misuse, alteration, unauthorized access and theft of personal data provided through the Website. In any case, you must take into consideration that Internet security measures are not impregnable.

### **What are your rights regarding your personal data?**

NGSC. informs you that you have the right to obtain confirmation as to whether or not we are processing personal data concerning you.

In the same way, NGSC. informs you that you have the following rights over your personal data: Access to your data: You have the right to access your data to know what personal data we are treating that concern you. Request rectification or deletion of your data: In certain circumstances, you have the right to rectify those personal data that you consider inaccurate and that concern you, and that are processed by NGSC, as well as the right to

request the deletion of your data when, among other reasons, the data are no longer necessary for the purposes for which they were collected. Request the limitation of the processing of your data: In certain circumstances, you will have the right to ask us to limit the processing of your data, in which case we inform you that we will only keep the data about which you have requested limitation in the processing for the exercise or defense of claims. To the portability of your data: In certain circumstances, you will have the right to receive the personal data concerning you, and that you have provided us, in a structured format for common use and mechanical reading, as well as to be transmitted by NGSC. to another data controller.

Object to the processing of your information: In certain circumstances and for reasons related to your particular situation, you have the right to object to the processing of your data in which case, we would stop processing them unless we must continue to do so for compelling legitimate reasons or for the exercise or defense of possible claims.

We also remind you that you have the right to object, at any time, to the sending of advertising of products and services of NGSC.

Finally, we inform you that you may file a complaint with the competent Data Protection Control Authority. However, in the first instance, you may file a complaint with the Data Protection Officer, who will resolve the complaint within a maximum period of two months.
